

U.S. AbilityOne Commission
Minutes – Quarterly Public Meeting
Tuesday, January 31, 2023
1:00 p.m. – 4:00 p.m. ET

I. Call to Order and Introductions

U.S. AbilityOne Commission Chairperson Jeffrey Koses called the meeting to order at 1 p.m. and greeted the 437 participants attending via Zoom.

Commission Executive Officer Angela Phifer gave administrative remarks. She noted that two American Sign Language interpreters would interpret, and that the meeting was being live captioned.

Commission members and Commission staff introduced themselves.

II. Consideration of Minutes

There were no changes to the minutes from the virtual public meeting on October 25, 2022. The minutes were approved.

III. Chairperson Opening Remarks

Koses said the meeting would include a panel on contract performance – a topic he himself spends a lot of time thinking about, since he is the Senior Procurement Executive for the General Services Administration (GSA).

Contract performance is not synonymous with the AbilityOne Program’s direct labor hour ratio requirement, he emphasized. Good contract performance showcases the work of AbilityOne in a competitive market, and results in increased customer satisfaction and better mission outcomes,

He noted that the Commission would soon begin a formal rulemaking process to support competition in the AbilityOne Program. The [2017 National Defense Authorization Act Section 898 Panel on Department of Defense and AbilityOne Contracting Oversight, Accountability and Integrity](#) had recommended that step.

“The value of competition within the Program is a message we hear loudly and clearly,” Koses said.

Koses went on to mention selected AbilityOne achievements in 2022, including:

He also discussed the Commission’s plans for [refocusing compliance](#) as part of the agency’s strategic initiatives to modernize and enhance AbilityOne.

IV. Remembrance of Bobby Silverstein

Commission Vice Chairperson Chai Feldblum and Katy Neas and Ralph Neas honored Bobby Silverstein, a pivotal figure in the advancement of disability policy, who passed away in November 2022.

V. Executive Director Report

Executive Director Kim Zeich [reported](#) on AbilityOne Program FY 2022 data, Commission accomplishments in the first quarter of FY 2023, and [AbilityOne Representatives](#) (ABORs) at Federal agencies.

VI. Presentation by Inspector General

Inspector General Stefania Porter provided an [update](#) on the activities of the Commission’s Office of Inspector General (OIG), including audits and the OIG’s FY 2022 Top Management and Performance Challenges Report.

VII. Regulations & Policy Subcommittee Updates

Commission Vice Chairperson Chai Feldblum gave an [update](#) on behalf of the Regulations and Policy Subcommittee, which she chairs:

- Commission [issued](#) three draft compliance policies on January 27, 2023, for public feedback.
- The new compliance policies will entail a fundamental shift for the Commission, Central Nonprofit Agencies, nonprofit agencies (NPAs), and stakeholders.
- On February 1, 2023, the Commission will pause routine, traditional compliance reviews in order to consider comments, retrain staff, develop updated compliance materials for the NPA community, and ensure alignment among all participants.
- While ongoing reporting and corrective actions will continue, the Commission will limit inspections to critical issues during this pause.

Feldblum also discussed the legislative changes to ABLE (Achieving a Better Life Experience) accounts, which are tax-advantaged savings programs for eligible people with disabilities.

VIII. Public Engagement: Federal Contract Performance

Acting Deputy Executive Director Amy Jensen moderated the meeting's public engagement section, which focused on Federal contract performance.

The Federal Register [notice](#) for the meeting had invited public comments and suggestions on the topic of what is important to Federal agencies in terms of contractor performance—whether or not those contracts are awarded under the auspices of the AbilityOne Program.

Eliana Zavala, Management Analyst, Office of Federal Procurement Policy

Zavala mentioned three Biden-Harris Administration acquisition priorities as being relevant to advancing equity for the disability community through procurement.

- The President's Management Agenda directs agencies to strengthen the diversity and resilience of the Federal marketplace.
- Source selection decisions should emphasize the best value to the taxpayer.

“This administration recognizes the great power of acquisition as a catalyst to advance our national priorities, from strengthening the competitiveness of U.S. industries to fighting climate change to strengthening cybersecurity,” Zavala said. “This will require strong performance from all of our contractors – performance that generates high customer satisfaction.”

- Important strides have been made in creating a more agile and innovative buying environment by encouraging testing and sharing of new ideas.

She emphasized the importance of information sharing.

Federal Customer Panel: Contract Performance Expectations

Justin Crosby, Department of Energy ABOR

Crosby raised points including:

- Mission success is shared success.

- Kickoff meetings can advance the understanding of a contract.
- Communicate early and often.
- The importance of knowledge management.

Sheila Roche, NASA ABOR

Roche raised points including:

- NASA expects contractors to provide quality products and services at a reasonable price with on-time delivery.
- NASA's contractor community needs to consider how the government can be more innovative in how it procures requirements.
- Even small solutions can make a big impact.
- Ideas can come from anyone at any level.
- NASA recognizes that innovation requires seeing issues from diverse perspectives to enable improved mission outcomes.

Linda Walker, Defense Health Agency (DHA) ABOR

Walker discussed questionnaires DHA sends out during the solicitation phase of a contract. The questionnaires are evaluated on recency, relevance and quality.

She also emphasized the importance of reading and understanding the requirements listed in a solicitation.

Following the panelists' remarks, Koses asked them to briefly discuss the role of Contracting Officer's Representatives (CORs) in contract oversight, and they did.

Koses asked the panelists to talk about any advice they would give to NPAs that are about to enter into a new contract.

- Roche emphasized the importance of understanding the terms and conditions of a contract. She also encouraged open communication with contracting officers and CORs, as appropriate.
- Crosby reiterated his points about kickoff meetings.
- Walker said it was important for contractors to know what is in their contract and stay in their lane.

Zavala discussed the importance of industry liaisons, and emphasized the value of sharing ideas, examples and success stories, including with the Commission and the ABOR community.

Millisa Gary, GSA ABOR, brought up the importance of trust. She also observed that ABORs can be resources for vendors as well as contracting officers.

Commission Member Tara Jamison, Deputy Senior Procurement Executive and Director, Office of Acquisition Management, Department of Justice, said a route to strong performance is to find opportunities that suit the skill set and talent of your particular organization.

Commission Member Matthew Beebe, Director of Acquisition, Defense Logistics Agency, said that NPAs should share information about their capabilities, including any new capabilities, as that can be helpful when looking ahead.

Zeich said she wanted to emphasize the theme of innovation that had surfaced in the conversation.

Feldblum tied the contract performance theme to the Commission's Strategic Plan. She also returned to the topic of the draft compliance policies, gave a little more information about next steps, and said compliance-related questions in the chat had been captured.

Koses closed the official part of the meeting.

IX. Tribute to Tina Ballard

Koses, Zeich, Commission Chief of Staff Kel Wood and others shared memories of Tina Ballard, who [passed away](#) on January 20, 2023. Ballard led the Commission from 2008 to 2021.
